Nirma students win national acclaim

A team of three students of Nitma. University, who have
been working on a project to
develop and reduce the cost
factor of manufacturing Aceckofenac
— a drug that works as pain relief, are
already making a mark in the field of
pharmacy.

Molssha Udani, Shreya Gupta and Anitrix Patel, final year students of chemical engineering department under the guidance of their professor Sanjay Patel, have been working on a process to develop Aceclofenac synthesis and its cost optimisation. This drug is costlier then Diclofenac, a widely used anti-inflammatory drug that has side effects such as gastrointestinal problems, etc. Aceclofenac is more effective pain relief then Diclofenac and has no side effects.

The trio has bagged various awards for this project: A fellowship from Consultancy Development Centre by the Government of India, Innovative Students Project award by Indian National Academy of Engineering (INAE) Delhi, Kerala Government Engineering Design National Award given by ISTE (Indian Society for Technical Education) and first prize in paper presentation in a national level technical symposium held at Vishwakarma College, Chandkheda. "The basic aim of this project was

"The basic aim of this project was to develop a process for Aceclofenac — an active pharmaceutical ingredient (API). Our present project deals with the process development and cost optimisation of aceclofenac synthesis," explained Moksh.

thesis," explained Moksh.
Said Shreya, "The patented process available for it, uses one of the major reactant which needs to be imported. This, therefore, becomes a costly affair and the patent does not even give detailed description." Through this method, the costlier raw material has been replaced with a cheaper raw material which is locally available and has no side effects. "Diclofenac costs Rs 20 while aceciofenac costs Rs 40. This tatio varies from 1:1,5 to 1:2, depending on brands," said Moksha.

The aim is to turn this into a com-

The aim is to turn this into a commercialised product. Said Antrix, "The final product has been developed after carrying out various experiments, within the norms laid by the Indian Pharmacopoeia and thereby the product can be supplied to the domestic market to start with." The trio aims at starting their own pharma industry in the next four years.



Effective Academic Strategies for Excellence in Higher Education

According to The National Knowledge Commission (NKC), higher education has made a significant contribution to economic development, social progress and political democracy in independent India. Still the prosperity of India vision-2020 depends upon key elements-education and knowledge. Our country is confronting with grave babbling problems in the field of higher education. As such there is burning need in the education sector for transformation in a way so as to ensure its great partnership in the development of India. Today, we are standing at a unique cross-road. One voice calls for need of globally competitive knowledge centres and the other to measure up with the rising expectations from the various stakeholders of academia. Change in education methodologies is a must and a natural process. Reforms are must to improve the methods of disseminating knowledge for not only economic dominance but also for overall development of India.

One of the most important key elements of academic process is - faculty. So, to improve the process, the step should start by treating the soul of the system. As such, a faculty is offered countless workshops, seminars, retreats and other training opportunities under the assumption that it can support effective teaching methods which in turn will percolate down to the students. But the empirical evidences are not favourable. They conform that this kind of training does not make a significant and lasting impact on teaching. Further more, we neglect the psychological consequences of the learning process that currently prevails in our institutes. We believe in 'tough standards' theory and always eye on favourable results. In this entire process, the impress should be on the quality of the process but not on the outcome. The time has come to realize the gravity of the present situation, recognize the solution and support the necessity of fundamental change as prudently suggested by NKC.

Another matter of deep concern is that the goal of teachinglearning differs sharply from the goal of students. The very basic issue is to keep students mentally productive throughout the class and to save them from lecture fatigueness. We need to say goodbye to all worn out methods and practices of the yesteryears that promotes to bookish and rot earning. The present system caters to rot learning that has unfortunately taken precedence over the more important qualities of analytical, reasoning, logical thinking, vision and problem solving skills. Student's involvement in the teaching process is the need of the hour. The measures should be taken to ensure active participation of the students thereby making the environment learner-centric over teacher-centric. When we talk of relevance of course curriculum to life skills, it has various dimensions associated with. Especially for engineering education, the course needs to be reengineered in a manner that it promotes learner-friendly, contemporary and research



driven activities. Its objective should be such set that it nurtures team dynamics among the learners alongwith a feeling of social accountability from the very beginning of their professional studies. The reformed methods should take optimum benefit of technology available for more clarity and ease in the teaching-learning process. It should provoke students' insight, thought process, ability to solve problems related to common man and upgrading their living standards. For this, interdisciplinary approach will be very apt to hone their creativity and innovative skills. Most importantly, the academic projects and assignments should be such designed that it involves their complete indulgence and reinforcing the application of fundamental theoretical concepts. Implementation of all these require set up of a dedicated centre/cell where basic facilities of all disciplines are available. The outcomes of such interdisciplinary cells installed in some of the foreign universities are simply amazing in terms of designing and developing cost effective products/services.

There is a further need to have synchronous environment to enhance the teaching-learning process where students and faculty can have ample scope to explore uncharted territories beyond the four walls of class rooms and boundaries of course curriculum. Academic/non-academic projects of creativity and innovation should be adequately funded to overcome financial constraints. Room for community service may be encouraged to inculcate social awareness among students and faculty.

In addition to above, it is time to wake up and make reformatory measures in the exam patterns which can scale the level of knowledge of a student in a tangible way. Now, we can no longer afford to remain complacent with archaic and didactic process of assessment pattern. Rather, it should be testing their comprehension and assimilation of concepts, application of concepts and knowledge of the subject. The question papers should be designed to evaluate their above skills rather than memory based learning. Grading should not be done in an arbitrary fashion or determined by a broad image of the student but a rationale one. A provision of comprehensive feedback should be made that can give opportunity to students for improvement through comments from the teacher conveyed in writing or in personal discussion. Moreover, such feedback will be relevant only if it is given immediately after the exam without much delay.

Overall, the present scenario of higher education in India offers a plethora of opportunities in the coming decades. All we need is to identify plagues in our education system and once the populace is enlightened it should find clear ways to implement the same. Active participation and acceptance should come from all the key elements of academic process right from faculty to student for realizing the redesigned course model in the benefit of mankind. It's high time that academic leaders should come forward to devise and implement new strategies and set higher standards in the academic world. As it is the ability of the leaders, to understand what has happened, is happening and may yet happen. And those who will grab the opportunity first and take proactive measures will be the winners.
