

Institute of Law, Nirma University bags Institutional Excellence Award, 2012:

Nirma University's Institute of Law has been adjudged and recognised for its high standard in legal education by The Society of Indian Law Firms (SILF), and Menon Institute of Legal Advocacy Training (MILAT) .Prof. (Dr.) Purvi Pokhariyal, the Director and Dean, Institute of Law and Shri D. P. Chhaya, Executive Registrar, Nirma University, received the award from Shri Lalit Bhasin, President of the SILF at a specially arranged function held in New Delhi on 7th September, 2012 in the presence of dignitaries and legal luminaries from across the country. The jury, under the Chairmanship of Justice J. S. Verma, former Chief Justice of India, unanimously selected Institute of Law, Nirma University for the Award from among the hundreds of law schools of its kinds among the SAARC countries. The SILF & MILAT also gave a Citation Certificate of appreciation which says that it is rare in the history of legal education for a law school to attain recognition as an institution on the road to academic and professional excellence within five years of its establishment. The leadership of the law school and the management of the University were appreciated for providing adequate infrastructural facilities, ample freedom to experiment with academic initiatives and sustained development of programmes of teaching and research. It also applauded the Institute of Law, Nirma University for providing an intensive and demanding programme of study for its under-graduate and post-graduate students from across the country.


Cultural Event




30,364 letters. He has been congratulated by the Chief Minister of Gujarat and been invited to meet him to show the Crossword Puzzle.
