#### **GUIDELINES FOR THE PAPER SUBMISSION:**

The soft copy of the contribution, as attachments in MS Word format (.doc) or (.docx) and PDF format (.pdf), must be sent to cihls@nirmauni.ac.in., where;

- An Abstract should be typed in **Times New Roman** with **1.5 spacing** and **Font Size 12** (Title Font Size 15). Abstract (not exceeding 300 words) should reach latest by 20<sup>th</sup>
   September in soft copy.
- 2. The Final Paper (not exceeding 3000 words) should reach latest by 20<sup>th</sup> October 2019 in Soft Copy.
- 3. The citation should strictly conform to the rules in The Bluebook: A Uniform System of Citation (20<sup>th</sup> edition).
- 4. Submission should include separate Title Page which clearly indicates the name(s) of e Page which clearly indicates the name(s) of the author(s), complete mailing address(es), Telephone No. and email address(es).
- 5. The text of the full paper and abstract must include title of the paper, but must not include the name(s) of the author(s) as the papers will be blind reviewed.
- 6. Co-authorship is allowed subject to a maximum of two co-authors.
- 7. Acceptance of the Abstract would be notified within a week of the receipt of the same. The complete paper should reach us latest by 20th October, 2019.

8. Only original unpublished work is sought. Any proposal submitted to present identical or substantially similar work already published or under review for any other publicationwill not be considered.

9. The four best papers will be rewarded.

10. Selected articles shall be published in the Conference Proceedings with an authenticated ISBN Number and a copy of the book as well as a certificate of publication shall be given

to each selected author.
