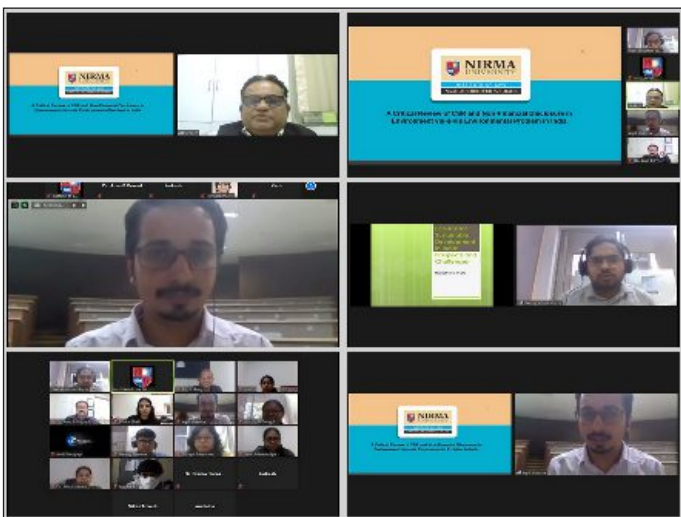

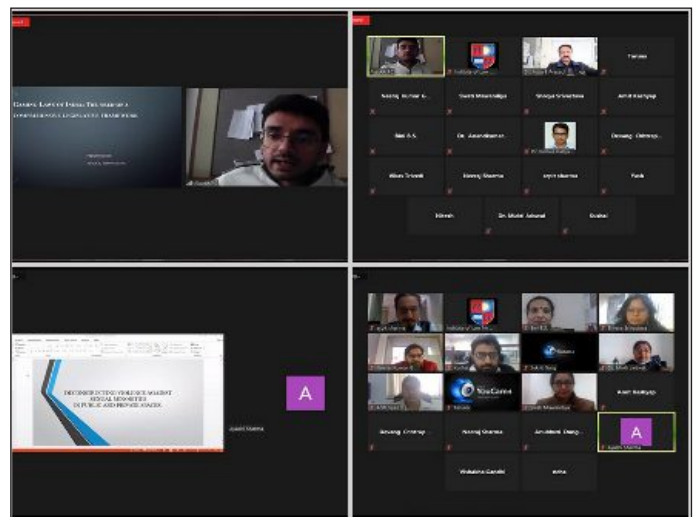
ILNU Seminar Series

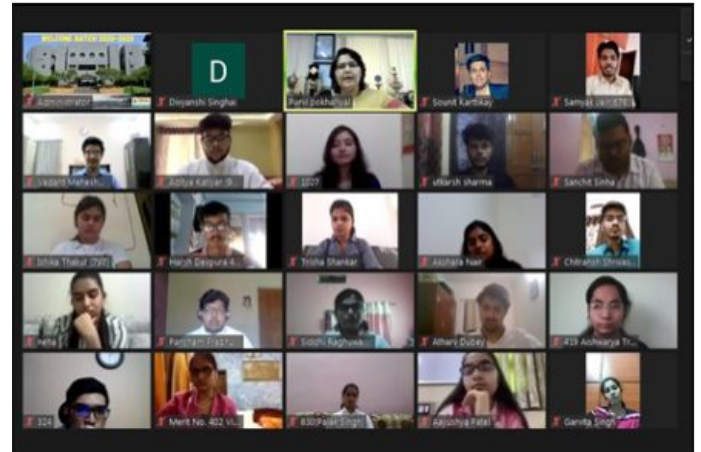

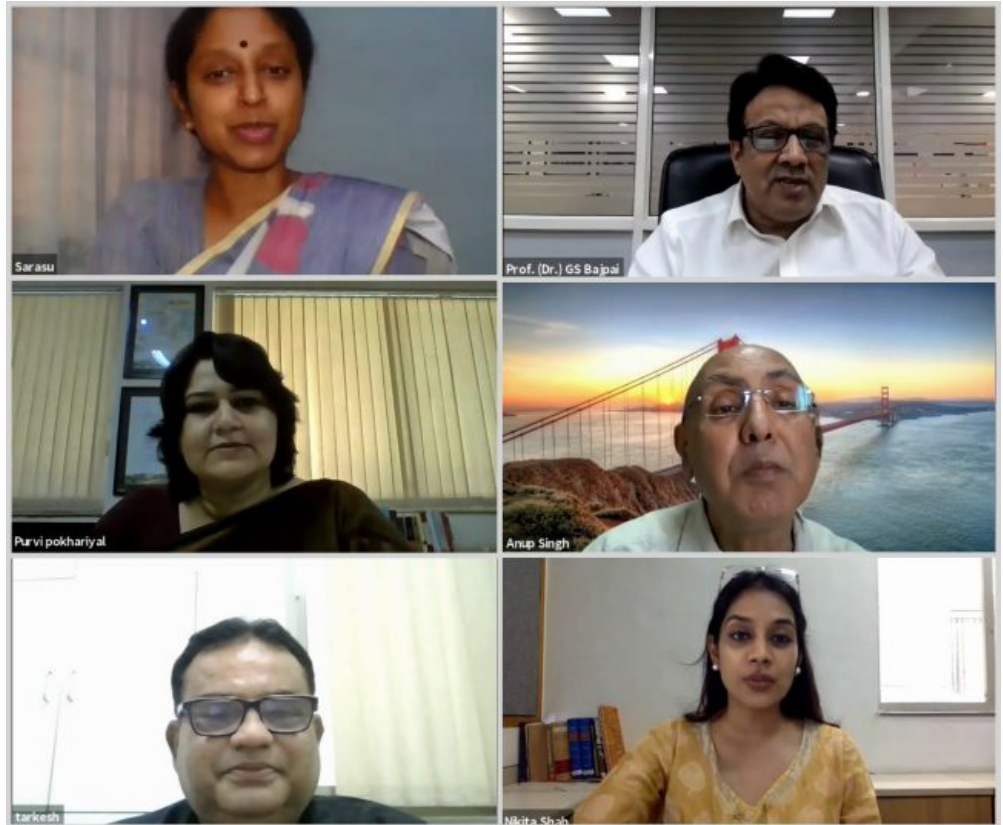

Speaking on the occasion, senior counsel of the Supreme Court Gopal Sankaranarayanan said an ocean of opportunities had opened up for all law students. Prof Stephen G Barnes from Penn State Law, USA, stressed on taking the road less travelled.
