- The duration of the project would be for one and half year starting from April 2018-September 2019. The select blocks include Paradi, Valsad, Bansda, Navsari, Netrang, Bharuch and Dharampur.
- 2. You would be provided financial assistance of INR 1,05,000/- total including all expenses. We expect minor local travel expenses of about INR 20,000 and rest towards human resources. While the INR 20,000/- will be paid during the assignment, all amount towards human resources will be paid only on completion of the project, acceptance of the report by us. If you utilize your vehicle you will be paid @INR 8 per km. In case of taxi usage you will be paid as per the bills.
- 3. You will keep the data and the work confidential and will not divulge to the third party.
- 4. You will be required to undertake following key tasks in the research.
 - a. Carry out desk research, compile all data on two decade time series (or as available) on social-economic changes, demographic changes, infrastructure/industrial changes, changes in the biodiversity (flora, fauna, water bodies, forest lands etc.), changes in agri-cropping patterns, mining etc.
 - b. You will map out policy contours impacting on biodiversity and ecology including industrial policy, health policy, urbanization policy, labor policy, agricultural policy, water policy especially ground water exploitation and status etc.
 - c. You will also map out relevant environmental laws existing in India impinging on the ecology scenario.
 - d. You will enlist all relevant international covenants India has agreed and is signatory.
- 5. You will be principal researcher for the project and will be working with out team.
- 6. We envisage most of the work of only desk research while our team will do limited field research as required by the project.
