Taking into consideration the documents referred as above (From 01 to 06) **Mr Patel Dharmendrakumar Bhagabhai** has been registered as Post Graduate student of the University for pursuing research for the degree of Doctor of Philosophy – **Ph. D (Part-Time) in Faculty of Technology & Engineering** with effect from 12/11/2016. His registration No. is 16PTVPHDE161.

He will work under the supervision of Dr. N.P.Gajjar, Professor, Institute of Technology who is a recognized Ph.D. Supervisor of Nirma University, Ahmedabad.. His registration is subject to observance of Ph.D Academic Regulations referred in sr. no.7 above which is attached herewith.

According to the provisions of regulations, he shall undergo the course-work as prescribed by the department based on the recommendation of Research Advisory Committee in conformity with R. Ph.D 5.3&5.4. Normally he will be required to complete the course work within initial two semesters (R.Ph.D 5.5) and earn 16 credits (R.Ph.D 5.1). However, in case of non-completion of course work within prescribed time limit, an extension up to additional one semester may be granted by Director General on the recommendation of Research Advisory Committee (R.Ph.D 5.5). Further he has to publish one paper in referred journal* and make two paper presentations in conference/ seminar acknowledging the name of Nirma University. (R.Ph.D 7.3 (ii)). For other regulations with regard to submission of synopsis etc refer document at sr.no.7 above.
