This is with reference to your proposal dated 19-02-2021 for sanction of 1 x 25 M³/day capacity Institutional Biogas Plant to your organization. I am directed to convey you the sanction of Director, GEDA for undertaking installation & commissioning of 1*25 M³/day capacity mixed waste based biogas plant at your proposed site under GEDA IBP Scheme 2020-21 with 75 % subsidy of total approved cost of Bio Gas Plant. The 1*25 M³/day capacity IBP should be installed and commissioned through GEDA's Authorized Contractor namely M/s. Sahas, Vadodara (selected by you) and as per specification & Design of GEDA..

Please note that in case, any details provided by you is found to be incorrect or false, the applicable subsidy for the project will be withheld / cancelled by GEDA.

The Installation & Commissioning of the plant shall be completed on or before March 2021. Necessary care may be taken to complete the work in stipulated time period and accordingly, the Authorized Contractor may be informed by you. Request of extension for completion of work shall be submitted 15 days advance to the Director, GEDA by you, if required.

The details of plant capacity & cost are as under:

a)	Plant capacity	: 1* 25 m ³ /day
b)	Cost of biogas plant (GGS)	: Rs. 7,53,000/-
c)	Cost Gas Distribution System	: Rs. 1,00,860/-
d)	Total Cost of plant (b+c)	: Rs. 8,53,860/-

Further it may be noted that 75 % subsidy on the plant cost shall be released by GEDA and 25% User share shall be borne by you. The subsidy portion of Gas Distribution System (GDS) shall be calculated & released on completion and commissioning of project work and actual measurement at site.

The subsidy shall be released to you/ Authorized Contractor in three installments as follows:

1. **40%** subsidy amount shall be released against completion of civil work (i.e. digester, feed & slurry handling system and fixing of central guide frame) along with photographic evidences & GEDA/Third Party Inspection Agency report .
2. **40%** subsidy amount shall be released against completion of work of fabrication of gas holder, along with photographic evidence, & GEDA/Third Party Inspection Agency report .
3. **20%** subsidy amount shall be released against
 - a) Laying of gas pipeline, construction of water removing chambers (WRC), initial feeding of plants, installation of burners,
 - b) Satisfactory commissioning & working of gas plants.
 - c) GEDA/Third Party Inspection Agency report
 - d) Submission of undertakings for operation, maintenance & running of the plant for a period of 10 yrs. from the USER Agency (on Rs.300/- stamp papers).

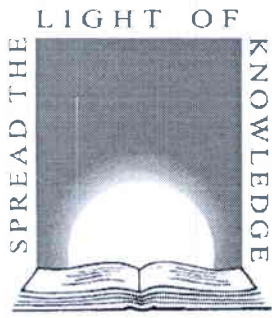
