The candidates must have passed the qualifying examination (BPharm) from a recognized university with minimum aggregate marks* or equivalent Cumulative Grade Point Index* (CGPI) or any other qualifying degree examination considered as equivalent of BPharm degree by Nirma University, Ahmedabad. (*as per PCI norms)

- Candidates who are appearing for the final semester of qualifying examination (BPharm)
 can also apply. In such case, the candidate is required to submit the result as soon as the
 same is available either by email or by fax (scanned image).
- If applicant has passed qualifying examination (BPharm) from a university other than Nirma University, then he/she will be required to obtain an eligibility certificate from Nirma University. The arrangement for obtaining the same will be made on the spot at the time of admission on payment of Rs. 1,000/- (Rupees one thousand only).

Admission procedure

- 1. 33% seats in all specializations of the M. Pharm program will be allocated through Admission Committee for Professional Courses (ACPC), Government of Gujarat.
- 2. The remaining 67% seats will be filled by the Admission Committee of the Institute of Pharmacy, Nirma University.
- 3. Priority will be given to eligible applicants with valid GPAT scores for admission in all the specializations. Admission decisions will be based on the merit of GPAT score.
- 4. Any seats remaining vacant after considering qualified GPAT candidates will be offered to non-GPAT candidates based on merit from a national-level computer-based entrance exam conducted on the day of counseling at the Institute of Pharmacy, Nirma University.
- 5. The entrance exam consists of multiple-choice questions and is designed similarly to the GPAT exam.
- 6. In the event of equal GPAT ranks or equal scores for Non-GPAT candidates, merit from the qualifying examination (i.e., BPharm) will be considered.

Important Instructions

- Participation in counseling does not ensure admission.
- Original documents must be presented during the admission process.
- Admission will be granted following the verification of testimonials and relevant documents.
- In the event of any dispute or uncertainty regarding the interpretation of any clause, the decision of the admission committee will be deemed final.
