

### Does PharmD program approved by PCI?

- Yes, PharmD program is approved by Pharmacy Council of India (PCI). 85% seats for 10+2 passed students of India with Physicals and Chemistry as compulsory course along with Mathematics or Biology or Both. 15% seats for NRI students.

### What is the mode of Application?

- Application can be done only through Online application portal from our website.

- Downloadable Application form (offline mode) is not available.
- Application Processing Fees (Rs. 1200/-) to be paid Online by Net Banking/ Debit /Credit card.

### Which are the documents required for online application? – Soft Copy of Following Documents

- Candidate's Photograph (JPG image)
- Marksheet: HSC examination (12th Std-10+2 pattern)
- Admission form Fees payment copy
- Any other certificates to be submitted as the Admission Committee deems necessary
- First attempt certificate is required

### What is the schedule for admission process?

### What is Eligibility for Admission?

A pass in any of the following examinations -

- (1) 10+2 examination with Physics and Chemistry as compulsory subjects along with one of the subjects, Mathematics or Biology or Both
- (2) Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examinations.

*Provided that a student should complete the age of 17 years on or before 31st December of the year of admission to the course.*

### What is admission process?

- After preparation of merit list, IPNU will announce the admission process to be held at IPNU based upon merit list and Candidates will be informed by email and/or website notification.
- Allotment of seats shall be made on the basis of merit and availability of seats.

- Students are required to report at the IPNU for conformation of admission and payment of the **fees Rs. 2.75 lakh / 5,000\* USD or its equivalent INR for the first year** on the day of admission through **Demand draft/Cheque prepared on the name of Institute of Pharmacy Under Nirma University.**
- In case the seats remain vacant after completion of first round of admission process, such vacant seats will be displayed on official website and next admission round may be conducted.

### What is the Fee Structure?

### What about the admission to international students' admission?

15% of total seats in each program being conducted at the constituent institutes of Nirma University, is available for admission to international students under the Supernumerary categories like Children of Indian Workers in Gulf Countries and South East Asia (CIWGC-SEA), Overseas Citizen of India (OCI) and Foreign Nationals (FN); out of which one-third i.e. 5% seats are earmarked for CIWGC-SEA and 10% for OCI/FN.
