

### Does MPharm program approved by PCI?

- MPharm program is approved by Pharmacy Council of India (PCI)

### What is the seat bifurcation for MPharm program?

- 33% seats will be filled by ACPC for all specializations of MPharm Program and the remaining 67% seats will be filled by Institute of Pharmacy, Nirma University.

### Which are the Specializations offered by Nirma University?

- MPharm is offered in specializations (approved by PCI) as follows.

<u>MPharm specialization</u>	<u>Max. intake</u>
Pharmaceutics	15
Regulatory Affairs	12
Pharmacology	12
Pharmaceutical Analysis	15

### What is the mode of application for 67% seats to be filled by the Institute?

- Application can be done only through online application portal from our website.
- Apply online: <https://admissions-ip.nirmauni.ac.in/>
- Downloadable application form (offline mode) is not available.
- Application processing fees (Rs. 1,250/-) to be paid online by net banking/ debit /credit card.

### Which are the documents required for online application?

#### Soft copy of the following documents:

- BPharm marksheets of all semesters/tears (up to the last declared result) in a single combined PDF File.
- Authenticated document for conversion from CPI/CGPA to percentage (wherever applicable).
- Valid GPAT score card (if applying as GPAT qualified category)
- Candidate's photograph (JPG image)

### What is the schedule for admission process?

Date for initiation of online application	3 <sup>rd</sup> June, 2024
Last date for online application	14 <sup>th</sup> July 2024

### What is Eligibility for Admission?

- BPharm from a recognized university with minimum aggregate marks or equivalent Cumulative Grade Point Index (CGPI) as per PCI norms.

### What is admission process for GPAT qualified candidates?

- Merit is prepared based on GPAT rank / GPAT score for GPAT qualified applicants.
- Admission would be offered based on merit of GPAT (with valid score).
- Candidate or authorized representative needs to present on the day of counseling.

### **What is admission process for candidates who have not appeared or not qualified in GPAT exam?**

- National level computer-based entrance exam would be conducted by Institute of Pharmacy, Nirma University for applicants.
- Entrance exam syllabus and pattern would be in-line with GPAT exam.
- Merit is prepared based on score of entrance exam only, for those who appeared for exam.
- Admission would be offered based on merit of entrance exam only.

### **When and where national level Computer-based entrance exam would be conducted by Nirma University?**

- Entrance exam would be conducted only at Nirma University Campus on the day of counseling.

### **How merit is prepared, if applicants have same scores?**

- If candidates have same score (GPAT or National Level online entrance exam conducted by Nirma University), then the result of qualifying exam (i.e. BPharm) is considered.

### **Can I apply, if my final year BPharm result is not declared?**

- Yes, candidate may apply as final year BPharm student. However, applicant has to submit result immediately after announcement from university.

### **What if my result is not announced before the date of counseling?**

- In case of non-availability of result on date of counseling, the admission would be offered on conditional basis along with undertaking from student and parent, to submit result immediately after announcement from university, as well as, candidate must have to pass with marks higher than minimum eligibility criteria for admission.

### **Can I change my preference for specialization filled in online application?**

- Yes. Applicant can change preferences in online application portal till last date of application. The final preferences would be obtained on the day of counseling.

### **What if I am not getting admission in my desired preference?**

- In such case, applicant may choose to get admission in next preferred specialization.
- During reshuffling process for vacant seat (in case of any cancellation received in future), admitted candidates would be reshuffled as per merit & final preference submitted on the counseling day.

### **Are there any reserve seats for candidates who did BPharm from Nirma University?**

- One seat (i.e. last seat) in each specialization is reserved for applicants, who have obtained BPharm from Nirma University.
- In case of no admission on such seat, then seat would be open for all as per merit.

### **What is the fee structure?**

- It is as per Fee Regulatory Committee (FRC), Gujarat state. Visit <http://www.frctech.ac.in/>

### **Are there different fees for different specialization?**

- Fee structure is same for all specializations.

### **Is there any financial assistance (monthly stipend) available from Nirma University?**

- GPAT qualified candidate would be eligible for monthly stipend of Rs. 12,400/-.
- Non-GPAT candidate would be eligible for monthly stipend of Rs. 8,000/-.

### **Is there any scholarship or loan available?**

- Institute supports applicant by providing necessary documents for obtaining scholarships from any society/Govt/NGO, for application to Education loan from Bank, for freship card formality of SC category students, etc.

### **Is there hostel facility available on campus?**
