Eligibility criteria

- The candidate must have passed the qualifying examination (B.Pharm or equivalent) in the relevant discipline from a recognized university, securing the minimum percentage of marks or equivalent Cumulative Grade Point Index (CGPI) as prescribed by the Pharmacy Council of India (PCI) and/or the Government of Gujarat, as applicable from time to time.
- Candidates who are currently appearing for the final semester of the qualifying examination (B.Pharm) are also eligible to apply. Such candidates must submit their final results immediately upon availability, either by email or by sending a scanned copy via fax.

Applicants who have obtained their qualifying degree (B.Pharm) from a university other than Nirma University must obtain an Eligibility Certificate from Nirma University. The facility for obtaining this certificate will be available on-site at the time of admission upon payment of a fee of ₹1,000 (Rupees One Thousand only).

Admission procedure

1. 33% of the seats in each specialization of the M.Pharm program will be allocated through the Admission Committee for Professional Courses (ACPC), Government of Gujarat.
2. The remaining 67% of the seats will be filled by the Admission Committee of the Institute of Pharmacy, Nirma University.
3. Priority for admission will be given to eligible candidates possessing a valid GPAT score, with selection based strictly on GPAT merit across all specializations.
4. Vacant seats, after considering qualified GPAT candidates, will be offered to Non-GPAT candidates based on merit determined through a national-level computer-based entrance examination conducted on the day of counseling at the Institute of Pharmacy, Nirma University.
5. The entrance examination will consist of multiple-choice questions and will be patterned closely after the GPAT examination.
6. In the event of a tie in GPAT ranks or equal entrance exam scores among Non-GPAT candidates, the merit of the qualifying examination (B.Pharm) will be used as the deciding factor.

- Original documents must be presented for verification during the admission process.
- Admission will be granted only after successful verification of all testimonials and relevant supporting documents.
