Expert Session on Importance of Legal Writing and Research



The Pro-Bono Club at ILNU organized a capacity building program at Gujarat National Law University & Parul University in collaboration with Department of Justice, Ministry of Law & Justice in which Mr. Alaukik Srivastava (Assistant Professor, ILNU & Faculty Coordinator of the club) was an invited speaker. 


A Group Discussion by CSJ

AKAM Essay, Drawing & Poster Making Competitions at ILNU




Three Book Displays
