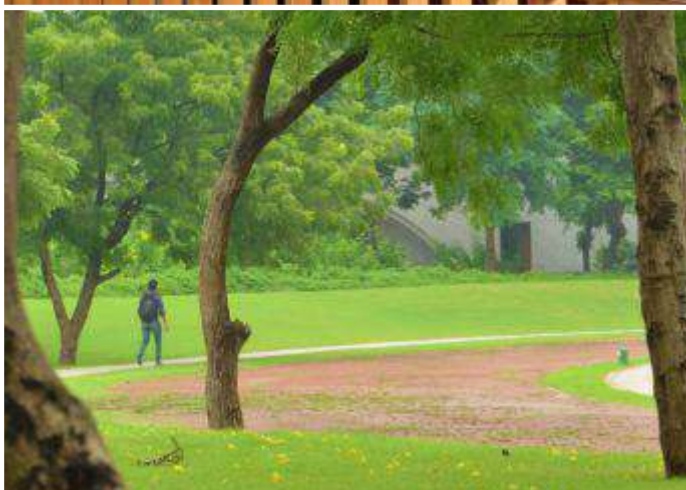
The Campus

Institute of Law is located in the Nirma University Campus which is on the Sarkhej-Gandhinagar Highway. This picturesque campus spreading over a hundred and twenty acres provides an ideal environment stimulating intellectual alertness and creativity. Green, energy-efficient, Wi-Fi enabled and designed to meet the academic and co-curricular requirements of the students, Nirma University Campus has a gymnasium and a number of playgrounds for students' recreational activities and sports events. The Campus canteens and cafeterias provide hygienic and healthy vegetarian food. Nirma University has efficient healthcare services on the campus, mindful of the physical and mental wellness of the students and the employees. A well-organized transport service is in place to enable effortless daily commuting.

Ensuring Students' Safety and Wellbeing on the Campus

The measures taken by the Institute of Law for ensuring the security of the students and employees on the campus are manifold. The campus is an alcohol and tobacco free zone, with guards and surveillance cameras ensuring round-the-clock security. The hostels offer safe and comfortable residential facility under the supervision of wardens and the faculty-in-charge. Students can discuss their problems and concerns with their assigned faculty mentors who conduct regular formal and informal meetings with them and are accessible on phone and email.

Institute of Law follows a zero-tolerance policy towards ragging and sexual harassment in accordance with the policies adapted by Nirma University. The Institute has an Anti-Ragging Committee and an Anti-Ragging Squad to ensure compliance with the relevant legal regulations and for prevention of ragging on the campus and hostels. The students are regularly sensitized on the norms concerning what constitutes ragging and how to seek redressal. Similarly, events focusing on prevention of sexual discrimination and harassment are organized from time to time to generate awareness among the students, faculty and staff. Nirma University has a rigorous system in place for prevention, prohibition and redressal of sexual harassment. Pedagogy

Institute of Law relies on a combination of pedagogical tools to provide the students with an efficient and scientific learning environment. The teaching/learning strategy targets expansion of knowledge, skills and aptitudes in a manner that leads to tangible outcomes. The courses offered aim at a holistic development of cognitive, critical, creative and practical abilities of the students. Evaluation methods are designed with a view of perceptively assessing the learning outcomes and skills acquired. Even at the undergraduate level, the students get ample prospects for exploring writing, research and publication in their areas of interest and expertise, under the guidance of competent faculty.

The curriculum offers opportunities for learners with different aptitudes and encourages self-learning. Faculty members keep track of the latest developments in their area of scholarship and are involved in active research. They make it a point to regularly engage students in research-based inquiry and learning. The students and members of the faculty publish regularly on such diverse platforms as blogs, newspapers, magazines and journals. The Institute of Law has identified significant domains of interdisciplinary knowledge relevant to legal studies and through its academic events and publications continue to explore these interfaces.

The Academic Research Centres under the supervision of faculty members with proven erudition and proficiency in each of these domains of knowledge facilitate rigorous learning and research. Further, there is an emphasis on the practical aspects of theory wherein students apply their conceptual knowledge to legal issues and problems. To enable the students to gain a better insight into the working of the legal profession, a practical work component has been added to all the courses.



The Library and Reading Rooms

Internships

As a part of the Clinical Legal Education Programme, the students undergo Internships after every semester during their tenure at ILNU. These internships are moderated and aided by the Campus Recruitment Cell. The winter and summer internships are mandatory and are a part of a supplementary course provided by the Institute.

Institute of Law has designed ten internship programmes for the students pursuing B.A., LL.B. (Hons.) and B.Com., LL.B. (Hons.) Degree Programmes. Placements

Those who have appeared in aforementioned exam and the result is awaited can apply for this programme. However, admission will be subject to the fulfillment of eligibility criteria at the time of admission.
