



INTERNATIONALIZATION at ILNU



A Certificate Course on Air and Space Law

The Institute organized a Six-Hour Certificate Course on 'Air and Space Law' on 14th & 15th February 2023. The aim of this course was to understand the key concepts underlying Air and Space Law through the various conventions, policies, and practices applicable to the domain. The course was coordinated by Prof. Ricky Lee (Professor of Law, The University of Notre Dame, Sydney, Australia). Professor Lee who is also a Senior Research Fellow with Jesus College, Cambridge, UK, interacted with ILNU students over the course of his stay on the campus.

A Certificate Course on Trial Advocacy

The Institute organized a Four-Hour Certificate Course on 'Trial Advocacy' from 15th February - 3rd March 2023. The course was coordinated by Judge Meg Flanagan (Judicial Educator, Adjunct Professor and a Fulbright Scholar, USA). The course improved students' skills in the court and helped them understand the practicality of trial advocacy.

A Distinguished Lecture on Implicit Bias and Impact of Democracies on Women

Women's Development Cell at ILNU organized a distinguished lecture on "Implicit Bias and Impact of Democracies on Women" on 24th February 2023 by Judge Mel Flanagan, (Judicial Educator, Adjunct Professor and Fulbright Scholar). Judge Mel is also Adjunct Professor at the Institute of Law, Nirma University. The resource person made the session interactive by giving the students small quizzes and making them take the test on Implicit Bias developed by Harvard University. The session was attended by almost 250 participants from Institute of Law, Management, Science and



Pharmacy including students, research scholars and faculty members.

A Distinguished Lecture on Women's Rights as Human Rights

Women's Development Cell at ILNU organized a distinguished lecture on "Women's Rights as Human Rights" by Prof. Adam Dubin (Assistant Professor of Law at Universidad Pontificia Comillas in Madrid, Spain) on 7th March 2023. He teaches subjects related to human rights as well as a course on LGBTQ Rights. The session focused on development of women's rights as human rights by discussing the three waves of feminism. The speaker also discussed the relevance of various international conventions such as CEDAW, DEVAW, and Beijing Declaration to highlight the importance of treating women's rights as human rights. He also elaborated on regional conventions applicable in the European Union on the same. The session was attended by almost 20 students.

An Expert Lecture by Stephen G. Barnes

The Institute organized an interactive session on 30th January 2023 for the faculty members of ILNU. The interactive session was presided by Stephen G. Barnes (Assistant Dean, Graduate and International Law, Pennstate Law, USA). Prof. Barnes highlighted the importance of research in the legal domain to overcome challenges which come with the advent of technology.

Participants have the chance to study alongside Penn State Law students, interact with faculty members, and experience the rich diversity of the Penn State community.

Penn State Law offers a comprehensive range of courses across various legal disciplines, providing exchange students with ample choices to tailor their academic experience. The program encourages students to explore specialized areas of law, such as business law, environmental law, intellectual property, criminal law and international law. RESEARCH CENTRE ACTIVITIES

MoU with Seattle University USA

The Institute of Law, Nirma University and Seattle University School of Law, Washington, USA, signed an LLM Partnership Agreement on 15th March 2023. The agreement provides for a 50 percent waiver in the tuition fee for ILNU students who have been nominated by the institute for postgraduate studies at Seattle University. The Agreement also aims to explore collaborative teaching, research and policy efforts in the areas of special courses, workshops, conferences and faculty visits.

The Institute organized XI Edition of National Students' Conference on "Urban Warfare and the Protection of Refugees" on 18th March 2023. It was conducted in collaboration with the United Nations High Commissioner for Refugees (UNHCR). The conference was an initiative by Centre for IHL and HR. The objective of the conference was to address core issues which plague the current Humanitarian and Refugee Law, which was beneficial to the student's fraternity.

ACADEMIC FIELD VISITS



Research in Progress: Major Research Project Field Visits

Under the Major Research Project category, Dr. Madhuri Parikh (Dean & Director I/c, ILNU as PI), Dr. Debaranjan Hota (Assistant Professor in Sociology as Co-PI), Dr. Neeraj Gupta (Assistant Professor in Law as Co-PI) along with three assistant researchers for their project titled "A Study on the Implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 in the State of Gujarat" sponsored by Tribal Research Institute, Government of Gujarat visited Dahod for Pilot study (3rd - 5th Jan'23) followed by Chhota Udepur (17th - 21st Jan'23), Mahisagar (2nd - 4th Feb'23), Surat (9th - 10th Feb'23), and Sabarkantha (16th - 17th Feb'23) across Gujarat. These visits included a brief interaction with the Officer in-charge of FRA implementation, data collection covering more than 20 villages. The team was also able to collect data from Revenue Officials, Officials working with Forest & associated offices. It turned out to be one of the rigorous exercises carried out for empirical research which helped the researchers gain new insights into the implementation of FRA in Gujarat.









Research in Progress: Minor Research Project Field Visit

Under the Minor Research Project category, Dr. Ashish Porwal (Assistant Professor in Finance & Accounting) for his project titled "An Investigation of Financial Literacy Among Undergraduate Students of Selected Universities of Ahmedabad" visited seven

External Experts in the area of Chattered Accountancy and Mutual Fund in Udaipur, Rajasthan. The experts were requested to comment on the questionnaire filled in by UG students on their own Financial Literacy as a part of this research. The experts gave their valuable advice on diversification of funds to minimize the risk. If students also possess the same opinion, then they will be considered to have Financial Knowledge of Risk Reduction through Diversification. The experts believe that students must have Financial Knowledge of Overspending because it will help them to organize their spending so that they will not go bankrupt. These insights proved to be an additional input in the on-going research.

Clinical Field Visits for Students

EIA Public Hearing: A Clinical Field Visit

The Institute conducted a Clinical field visit to Tejpur village of Mehsana District and Sanand District in Gujarat. It was a 'Public Hearing for Environmental Approval on the proposed project with respect to Expansion of Metallurgical Industries (Ferrous and Non-Ferrous) Unit' of M/s Steel Strips Wheel Ltd. on 3rd March 2023. A total of 240 Third Year students went to this field trip in two slots under the guidance of faculty coordinators Mr. Abhinav Kumar,



Gururaj Devarhubli, Mr. Arpit Sharma and Dr. Bharat Rathore. The company explained their working mechanism to the locals and environmentalists of their region. The students found the visit thought-provoking and insightful.

A Visit to Consumer Disputes Redressal Commission

The Institute organized a visit to Consumer Disputes Redressal Commission on 2nd February 2023. Around 40 students from First Year Undergraduate program attended a session on Consumer Protection Act 2019 wherein students were oriented towards important provisions of the said legislation.
