


Exam Orientation for Students

EXPERT LECTURES

Expert Session on An Overview of Civil and Criminal Litigations

An expert session on 'Overview of Civil/Criminal Litigations: A Professional's Perspective' was organized on August 21, 2023 for the First-Year students at ILNU. The invited speakers were Adv. 


Expert Lecture on Writing in Exams




ILNU Library organizes Books' Display Activity


