Exposure - to practical aspect of law

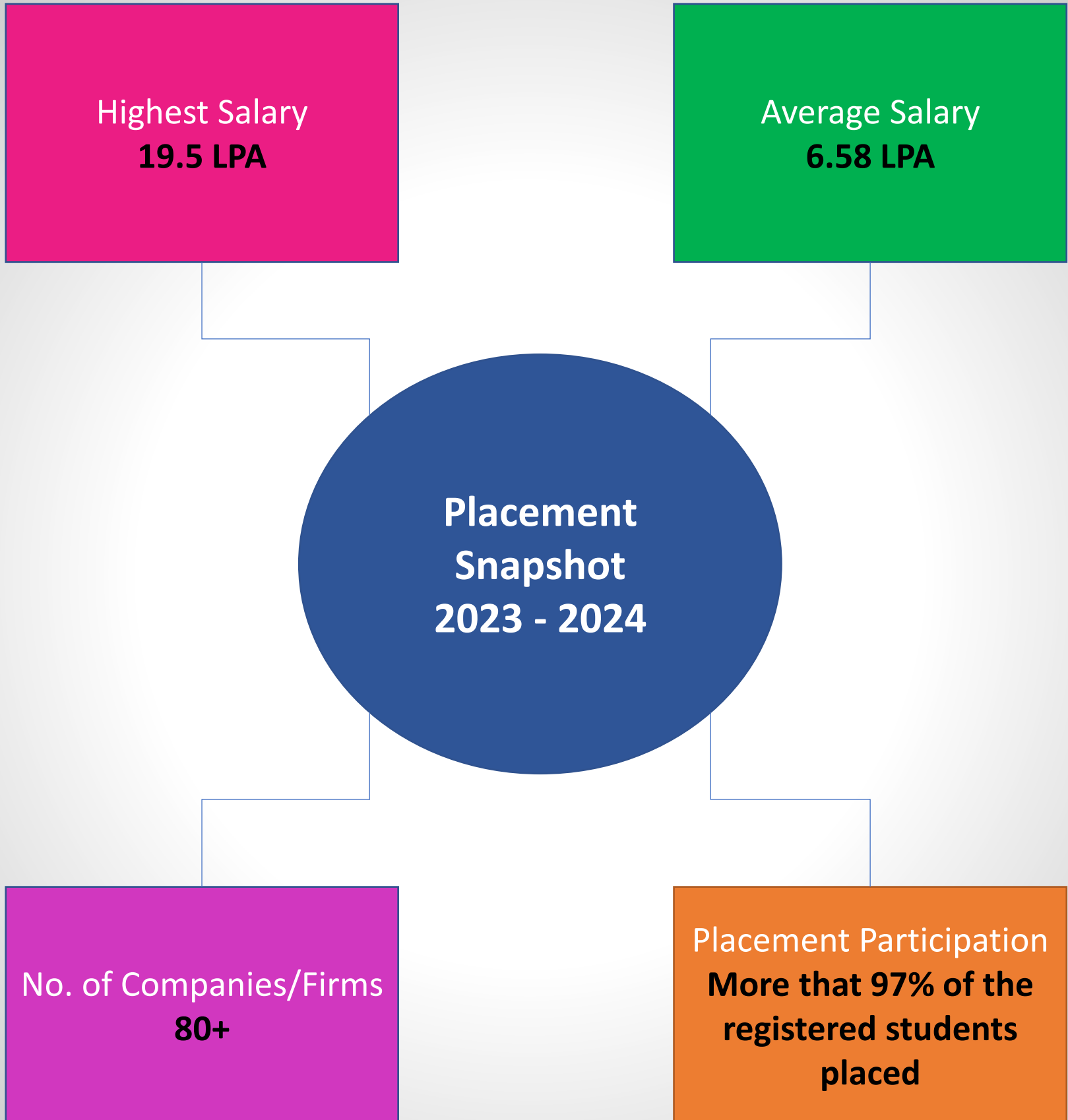
Application - of law in various situations and correlating it with theories taught in class
