Candidates who are willing to secure admission to vacant seats arising after online admission of B.Arch. program Round-2 at Grant-In-aid institutes, CEPT Uni., Nirma Uni. for academic year 2025-26 are here by informed to follow procedure as per following instructions and schedule.

Note: The admission shall be subject to availability of Vacant Seats (Due to Non-Reporting and Withdrawal) in the concerned course and institute at the time of Counselling subject to fulfilling of all eligibility requirements as per prevailing admission rules led by Council of Architecture(CoA) and Govt. of Gujarat for B.Arch. Course.

### Steps/Instructions for Participation in Vacant Quota Round in Grant-In-Aid (GIA) institutes, CEPT Uni., Nirma Uni.

1. **The candidates who are in merit list B.Arch. admission process of ACPC** and willing to take part in Counselling process of offline round of vacant seats in Grant-In-Aid institutes (GIA) Institutes, CEPT Uni., Nirma Uni. shall have to register online by filling registration form through the link mentioned below:

- on 29.08.2025 from 10:00 A.M. to 3:00 P.M. It is compulsory to fill the online registration form to participate in Counselling process of offline round of vacant seats in Grant-In-Aid institutes (GIA) Institutes, CEPT Uni., Nirma Uni.
- 2. The candidates who have not registered in online B.Arch. admission process of ACPC and fulfilling eligibility criteria as mentioned in rule-5 of admission notification, Education Department, Gujarat Government for B.Arch. course can do new online registration by filling online registration form through above mentioned link on 29.08.2025 from 10:00 A.M. to 3:00 P.M.
- 3. Newly registered candidates have to pay Registration Fee 350/- (Non Refundable) in cash at the time of Counselling.
- 4. There is no other means of applying for the candidature for this offline round of admission on vacant seats in Grant-In-Aid

institutes (GIA) Institutes, CEPT Uni., Nirma Uni.. Therefore, candidates who do not register online as stated above with in prescribed time limit shall not be allowed to participate in this round of admission.

- 5. The merit list will be prepared as per the prevailing rules of Government of Gujarat and will be declared on admission committee website https://acpc.gujarat.gov.in/b-arch-courses on 30.08.2025 at 10:00 AM
- 6. Candidates have to carry original certificates and photocopy of certificates at the time of Counselling. After verification of original certificates; the eligible candidates will be allowed to participate in Counselling process.
- 7. If the candidate is unable to attend the admission in person, parents can duly represent them at the counselling session by presenting an authority letter.
- 8. If the candidate gets admission, then candidate has to pay token tuition fee in cash during Counselling. There is no tuition fee for a girl candidate for admission in a Grant in aid institution.
- 9. After allotment of admission to the candidate, it is necessary to report to allotted institute by 31.08.2025. If any candidate does not report within the stipulated time, such candidate will not have any claim for admission.
- 10. Candidates who do not have merit number or are yet to register in offline vacant seat Counselling will be allowed to do spot registration at 4.00 pm on 30.08.2025.
- 11. If candidate gets admission in offline round, then candidate has to cancel his/ her previous online round admission at institute level by himself / herself before 31.08.2025. Token tuition Fee refund will be done on the basis of Government rules
- 12. The admission shall be subject to availability of Seats in the concerned course and institute at the time of Counselling subject to fulfilling of all eligibility requirements as per prevailing admission rules led by Council of Architecture(CoA) and Govt. of Gujarat for B.Arch. Course.
- 13. Since this admission procedure is on vacant seats as per prevailing rule-20 of the admission notification available on committee's website.
- 14. The details of vacant seats are as stated above, the Eligibility criteria, Notifications for admission to B.Arch. course and other relevant details are available on committee's website.
- 15.
