**Cancellation of Admission & Refund Policy**

**Integrated BTech (CSE) – MBA Programme**  
**(All India & NRI/NRI-Sponsored Category)**

**Cancellation of Admission:**

- The candidates may cancel the provisional admission by clicking the link (Cancellation Link for Integrated BTech (CSE) MBA) available in the “Seat Cancellation” Tab on the dashboard of candidate’s login.
- The candidate has to mention the required details correctly and must have to upload the clearly visible copy of the cancelled cheque along-with the cancellation request.
- The refund will not be issued in case of filling in-correct cheque details as well as not uploaded the cancelled cheque.
