**Cancellation of Admission:**

- The candidates may cancel the admission through online cancellation module named “**Seat Cancellation**” available on the Dashboard of the candidate’s account only.

- The candidate has to fill the cancel cheque details correctly and must have to upload the clearly visible copy of the cancelled cheque along-with the cancellation request.
