## **Cancellation of Admission:**

- The candidates may cancel the admission through online cancellation module named "Seat Cancellation" available on the Dashboard of the candidate's account only. URL: https://admissions-it.nirmauni.ac.in/student/default.aspx
- The candidate has to fill the cancel cheque details correctly and must have to upload the clearly visible copy of the cancelled cheque along-with the cancellation request.
- The refund will not be issued in case of filling in-correct cheque details as well as not uploaded the cancelled cheque.
