### 1. Apply Online:

Candidate has to **apply online** on the website URL:

(<https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>)

### 2. Application Form Fee:

- **INR 350/- [non-refundable]** for the candidate appeared in 12th board examination from the school located **in the State of Gujarat** (including Daman and Diu or Dadra Nagar Haveli (UT).
- **INR 1200/- [non-refundable]** for the candidate appeared in 12th board examination from **the school located outside the State of Gujarat** (including Daman and Diu or Dadra Nagar Haveli (UT).

**Note:** If any candidate is outside the state of Gujarat and paid the application form fee INR **350/-**, his/her application form will be disqualified.

### 3. Mode of Payment:

Payment must be made online through **Credit Card / Debit Card/ Net Banking**. Your application will be treated as complete only after the successful payment of an application fee and allotment of registration number.

## **Admission Rules**

The 52% seats of intake shall be filled by Institute of Technology, Nirma University under the category of All India seats from the candidates who have passed the qualifying examination from the schools located in India (including Gujarat State).

### **1. Eligibility:**

1. Candidate must have appeared in Paper – I of JEE (Main)-2024 Entrance Examination.
2. Candidate must have passed 12<sup>th</sup> Science Examination with **Physics and Mathematics with (Chemistry or Biology or Computer or Technical Vocational Subject)** from single board with the percentage of marks as to be decided by the Government of Gujarat (GoG) under the rules of admission.

### **2. Mode of Admission:**

1. These seats shall be filled-in by the candidates who have passed 12<sup>th</sup> Science Examination with above mentioned subjects from the school located in India (including Gujarat State) on the basis of All India Rank (AIR) in Paper – I of JEE (Main)-2024 Entrance Examination.
2. Online application form is available on the website and same should be filled with correct information (as per the instruction) and make payment by **Net banking / Credit card / Debit card/UPI**.
3. The provisional merit list along-with detailed programme of online allotment / offline counseling will be displayed on the website / admission portal.
4. The filled application form (online), Score card of JEE (Main)-2024 and Mark Sheet(s) of HSC (Std. 12<sup>th</sup>) examination need not to be sent to the Institute.
5. In case, Letter Grade / Performance Index or Graded Point Average is awarded, instead of percentage marks/percentile in qualifying examination, the equivalence certificate issued by the school authorities shall be required on the day of counselling of admission.
6. Online counseling will be carried out as per the schedule declared on the website and admission portal for the admission to First Year B.Tech. Programme 2024. The allotted admission seat of the candidate will be confirmed only after the successful payment of necessary fees, subject to verification of Eligibility and necessary documents.

7. After conducting online allotment rounds, if required, offline (In-person) / telephonic counseling will be carried out and the schedule will put-up on the website. The candidate has to report (if required) within stipulated time as per the schedule at Institute of Technology, Nirma University, and Ahmedabad.
8. Candidate is required to follow admission procedure and schedule, declared time to time at the office of the Institute and website.
9. Note that information about the admissions process will only be updated on the applicant dashboard and admissions webpage. There won't be any further correspondence via text or email. It is the responsibility of applicants to check these sites on a regular basis for updates or notifications.

### **3. Preparation of Merit List:**

The merit list will be prepared based on the All-India Rank (CRL) of Paper – I of JEE (Main) – 2024 Entrance Examination declared by NTA.

### **4. Online Allotment / Counseling Process:**

1. Candidate has to fill up the branch choices, at the time of filling up the online application form.
2. **The candidate can modify their filled branch choices up to the last date mentioned on the website.**
3. **The filled branch choices will be locked automatically after the last date.**
4. As per the locked choices, admission committee will carry-out **one or more online allotment rounds** for allotting the seats and declare the status of allotment on the admission portal. The candidates may view their status of allotment in their account, by login to the admission portal using their login credentials.
5. After each online allotment, following four options will be given to the selected (on the basis of merit) candidates in their dashboard and they are required to select any one out of these four options during the stipulated time duration, **failing which his / her candidature deemed to be cancelled.**

**Option A. I accept the branch allotted to me and I do not want any up-gradation in branch allotted. I will pay the required fees within the time limit. I will also report online/offline as per the schedule. Failing which I will not have any right for admission to Institute of Technology, Nirma University.**

**Option B.** I accept the branch allotted to me and I will pay the required fees within the time limit, however I want to remain in counseling process for branch up-gradation. Branch upgraded as a result of reshuffling will supersede the current branch allotted and is binding to me.

I will also report online/offline as per the schedule. Failing which I will not have any right to admission in the branch made available to me at Institute of Technology, Nirma University.

**Option C.** I am not interested in allotted branch but I want to remain in counselling process for branch up-gradation.

**Option D.** I am not interested in branch made available to me as well as I do not want to remain in counselling process for branch up-gradation. (As soon as candidate selects this option, he/she will be out of counselling process at Institute of Technology, Nirma University).

**Note:**

- 1. If you select Option A or Option B, it is mandatory to deposit the required amount of fees through online mode immediately and enter the required details of payment.**
- 2. If you fail to deposit the fees in stipulated time duration, your admission is liable to be cancelled and you will be out of the counselling process.**
- 3. If candidate does not choose any of the above options within stipulated time duration, Option 'D' will be considered by default and the candidate will be out of the counseling process.**
- 6. Candidate can cancel the admission through online cancellation module available in candidate's dashboard only. Candidate has to fill the required details and upload the clearly visible copy of the cancelled cheque during online cancellation. Also submit the original fees paid receipts as well as admission order (issued during the document verification process) along with the print-out of cancellation request within one week to the Institute through post/courier. **Failing to do so, the refund process will not be initiated.****

**5. Interpretation of Clauses:**
