

## 1. Online Allotment Process:

- 1. The filled branch choices are locked automatically after the stipulated time period (i.e. last date) given in the schedule.
- 2. As per the locked choices, admission committee will carry one or more online allotment rounds for allotting the seats and declare the status of allotment in the Dashboard of the candidate. The candidates may view their status of allotment by login to their account.
- **3.** After each online allotment, following four options will be given to the selected (on the basis of merit) candidates in their accounts and they are required to select any one out of these four options, failing within stipulated time duration his / her candidature deemed to be cancelled.
  - <u>Option A</u>. I accept the branch allotted to me and I do not want any up-gradation in branch allotted. I will pay the required fees within the time limit **(as mentioned on the website)**. I will also report online/offline as per the schedule. Failing which I will not have any right for admission to Institute of Technology, Nirma University.
  - Option B. I accept the branch allotted to me and I will pay the required fees within the time limit (as mentioned on the website), however I want to remain in counseling process for branch upgradation. Branch upraded as a result of reshuffling will supersede the current branch allotted and binding to me. I will also report online/offline as per the schedule. Failing which I will not have any right for admission in the branch made available to me at Institute of Technology, Nirma University.
  - **Option C**. I am not interested in allotted branch but I want to remain in counselling process for branch up-gradation **(Select within the stipulated time)**.
  - <u>Option D</u>. I am not interested in branch made available to me as well as I do not want to remain in counselling process for branch up-gradation. As soon as candidate selects this option, he/she will be out of counselling process at Institute of Technology, Nirma University.

Note:

- 1. If you select Option A or Option B, it is mandatory to deposit the required amount of fees through online mode immediately and enter the required details of payment.
- 2. If you fail to deposit the fees in stipulated time duration, your admission is liable to be cancelled and you will be out of the counselling process.
- 3. If candidate <u>does not choose</u> any of the above options within stipulated time duration, <u>Option 'D'</u> will be considered by default and the candidate will be out of the counseling process.
