

Cancellation of Admission and Refund Policy (REVISED) BTech Programme (A.Y.– 2024-25) ALL INDIA CATEGORY & NRI/NRI-SPONSORED CATEGORY

Cancellation of Admission:

• The candidates may cancel the admission through online cancellation module named "Seat Cancellation" available on the Dashboard of the candidate's account only.

- The candidate has to fill the cancel cheque details correctly and must have to upload the clearly visible copy of the canceled cheque along-with the cancellation request.
- The refund will not be issued in case of filling in-correct cheque details as well as not uploaded the canceled cheque.

Refund Policy:

Sr. No.	Details of Cancellation	Deductions (INR) & Refund
1	Cancellation of admission on or before 02/07/2024 (23.59 pm) through online cancellation module.	INR 1000/- processing charge will be deducted. The remaining fees will be refunded after 30/09/2024.
2	Cancellation of admission after 02/07/2024 (23.59 pm) but on or before 30/08/2024 (23.59 pm) through online cancellation module.	INR 1000/- processing charge will be deducted. The remaining fees will be refunded after 31/10/2024, subjected to the condition that such vacated seat being filled-up by the Institution from the next candidate as per merit of respective category. Note for NRI/NRI-Sponsored Category: If the vacated NRI/NRI-Sponsored Seat will not fill-up through the next candidates as per merit of respective category for any reason whatsoever, the admission team will try to fill-up the said vacant seat from the candidates of All India as well as ACPC Vacant Seats and if the seat fill-up, the fees received from the candidate will only be refunded and the difference of NRI Fees will be forfeited.
3	Cancellation of admission <u>after</u> 30/08/2024 (23.59 pm) through online cancellation module.	Entire paid fee will be deducted. Only refundable security will be refunded after 31/10/2024.
