## B. Tech. Admission-2024 (ACPC VACANT SEATS)

### Information Letter for In-person counseling of ACPC Vacant Seats.

Dear Candidate,

Institute has scheduled In-person counseling for admission to first year B. Tech. Programme under ACPC Vacant Seats. With reference to this, **you are hereby informed to remain present as per the scheduled mentioned on the website at your own cost.**

The candidate must have passed the qualifying examination (Individually in all the subjects and collectively) and secured minimum eligibility criteria as mentioned in the guidelines of ACPC, GoG.

**Also, the candidate has to bring the under mentioned documents with two sets of photocopies and two passport size photographs.**

**(Two sets of photocopies one for verification of Eligibility & another one for reporting)**

- Std. 10<sup>th</sup> (SSC) Mark-sheet
- Std. 12<sup>th</sup> (HSC) Mark-sheet
- School Leaving / Transfer Certificate (Issued by school)
- GUJCET-2024 Mark-sheet
- ACPC Registration Letter-2024 (Mentioning ACPC Rank)
- Aadhar Card of Candidate

**Note: The candidate is informed to bring the original of all the above documents for verification only. There is no need to submit the original documents at the Institute.**

It is the responsibility of an applicant to remain present for In-person counseling on scheduled date and time. If applicant is unable to remain present In-person due to unavoidable circumstances, parents with authority letter from the applicant will be permitted, provided the Admission Committee is satisfied for the genuineness about the applicant's inability to remain present. If applicant does not remain present at the scheduled date and time and presents himself afterwards, he/she will be offered admission in the branch available at that time.

**In case admission is confirmed, the candidate will be required to pay ₹ 127500/- (one semester fee) on same day by at par cheque drawn in favour of "Institute of Technology, Nirma University" payable at Ahmedabad as way of confirmation of admission. Failing to do so the admission will be treated as cancelled.**

If applicant has passed 12<sup>th</sup> Science examination from **board other than Gujarat Higher Secondary Education Board**, he/she will be required to obtain the eligibility certificate from Nirma University on cash payment of **Rs.1000/- (non-refundable)** for which arrangement is made to issue the same on the spot.

**Only one parent along with the candidate is allow to the reporting venue as per the schedule mentioned on the website.**

Your admission deemed to be confirmed if and only if you complete all the formalities including In-person reporting, fulfilment of eligibility, payment of fees etc. The merit list is electronically generated. The admission committee is not responsible for any inadvertent mistake that might have crept in. This Information Letter does not guarantee for the admission to B. Tech. Programme and allotment of seat will be strictly on merit and availability of seat.
