- ₹<u>350/- [non-refundable]</u>) for the candidate appeared in 12th board examination from the school located in the State of Gujarat (including Daman and Diu or Dadra Nagar Haveli (UT).
- ₹<u>1200/- [non-refundable]</u>) for the candidate appeared in 12th board examination from the school located outside the State of Gujarat (including Daman and Diu or Dadra Nagar Haveli (UT).
- <u>Note:</u> If any candidate's school is located outside the state of Gujarat and paid the application form fee ₹<u>350/-</u>, his/her application form will be disqualified.

Admission Rules:

The 15% seats of the total intake shall be filled by Institute of Technology, Nirma University under the category of NRI / NRI-Sponsored from the candidates who have passed the qualifying examination from the schools located abroad or in India (including Gujarat State).

1. Eligibility for Non-Resident Indians (NRI) Candidate:

- Candidate must have passed the qualifying examination <u>abroad</u> and is exempted from appearing in Paper – I of JEE (Main)-2025 Entrance Examination.
- Candidate who has passed the qualifying examination from the <u>school located in India</u> (having NRI status) must have to appear in Paper I of JEE (Main) 2025 Entrance Examination.
- 3. In case, Letter Grade / Performance Index or Graded Point Average is awarded instead of percentage marks in qualifying examination, equivalence certificate is required from the school authority.



2. Eligibility for NRI-Sponsored Candidate:

- Candidate must have passed the qualifying examination in India and must have appeared in Paper – I of JEE (Main)-2025 Entrance Examination. The admission will be offered based on the merit list prepared as per All India Rank (CRL) of Paper – I of JEE (Main)-2025 Entrance Examination only.
- 2. Candidate will have to produce a sponsorship letter (as prescribed) from an NRI who will undertake to pay all tuition and other fees for the entire degree program.
- 3. Documentary evidence of Sponsor having NRI Status must also be produced.
- 4. In case, Letter Grade / Performance Index or Graded Point Average is awarded instead of percentage marks in qualifying examination, equivalence certificate is required from the school authority.

3. Mode of Admission:

- Online application form is available on the website and same should be filled with correct information (as per the instruction) and make payment by Net banking / Credit card / Debit card/UPI.
- The provisional merit list with detailed Programme of counseling will be displayed on website.
- These seats shall be filled-in by the NRI Candidates who have passed 12th Science Examination with above mentioned subjects from the school located abroad on the basis of percentage of 12th Board Examination. The first priority in admission will be given to NRI Candidates.
- After giving admission to the NRI Candidates, the remaining seats shall be filled-in by the NRI-Sponsored candidates who have passed 12th Science Examination with above mentioned subjects from the school located in India (including Gujarat State) on the basis of All India Rank (AIR) in Paper – I of JEE (Main)-2025 Entrance Examination.
- After conducting online allotment rounds, if required, offline (In-person) / telephonic counseling will be carried out and the schedule will put-up on the website. The candidate has to report (if required) within stipulated time as per the schedule at Institute of Technology, Nirma University, Ahmedabad.



4. Preparing of Merit List:

NRI:

The merit list will be prepared considering percentage obtained in theory subjects of Physics, Mathematics and Chemistry or Biology or Computer or Technical Vocational Subject of Std.12th Science or equivalent examination.

NRI-Sponsored:

The merit list will be prepared considering All India Rank (CRL) of Paper – I of JEE (Main) – 2025 Entrance Examination declared by NTA.

5. Counseling Process:

- 1. Candidate has to fill up the branch choices, at the time of filling up the online application form.
- 2. The candidate can modify the branch choices up to the last date mentioned in the tentative schedule on the website.
- 3. The filled branch choices will be locked automatically after the last date.
- **4.** As per the locked choices, admission committee will carry-out online counseling rounds as per the schedule mentioned on the website.
- 5. In case, admission is confirmed, candidate will be required to <u>pay one semester fees as</u> <u>mentioned on the website as way of confirmation of admission</u>. Failing to do so the admission will be treated as cancelled.
- 6. If candidate has passed 12th Science examination from board other than Gujarat Higher Secondary Education Board and if candidate confirms his/her admission, he/she will be required to obtain the eligibility certificate from Nirma University on payment of ₹<u>1000/- (non-refundable)</u> through online mode.
- 7. Candidate can cancel the admission through online cancellation module available in candidate's dashboard only. Candidate has to fill the required details and upload the clearly visible copy of the cancelled cheque during online cancellation. Also submit the original fees paid receipts as well as admission order (issued during the document verification process) along with the print-out of cancellation request within one week to the Institute through post/courier. Failing to do so, the refund process will not be initiated.
