

BTECH ADMISSION – 2025
FAQs
(15% NRI / NRI-Sponsored Seats)

Q. 1. I am interested in joining B. Tech. Programme at Institute of Technology, Nirma University under NRI /NRI-Sponsored Category Seats. When can I apply?

Candidates can apply online.

- The online application starts from **20/02/2025**.
- The last date of online application is **Refer Website**.

Q. 2. How much is the application form fee?

The application form fee is as under:

- **₹350/- [non-refundable]** for the candidate appeared in 12th board examination from the school located in the State of Gujarat (including Daman and Diu or Dadra Nagar Haveli (UT).
- **₹1200/- [non-refundable]** for the candidate appeared in 12th board examination from the school located outside the State of Gujarat (including Daman and Diu or Dadra Nagar Haveli (UT).
- **Payment will be made online through Credit Card / Debit Card / Net Banking/UPI.** Your application will be treated as complete only after the successful payment of an application fee and allotment of registration number.

Q. 3. What are the eligibility criteria for admission to B. Tech. Programme in Institute of Technology, Nirma University under NRI /NRI-Sponsored Category Seats? What subjects I must have opted in Std. XII (Science Stream)?

1. Candidate must have passed the qualifying examination abroad and is exempted from appearing in Paper – I of JEE (Main)-2025 Entrance Examination.
2. Candidate who has passed the qualifying examination from the school located in India (having NRI status) have to appear in Paper – I of JEE (Main)-2025 Entrance Examination.
3. In case, Letter Grade / Performance Index or Graded Point Average is awarded instead of percentage marks in qualifying examination, equivalence certificate is required from the school authority.

Q. 4. Whether marks for the std. XII (10 + 2) examination will be considered for the admission to B. Tech. Programme?

Yes, only for NRI Candidates.

Q. 5. Which examination is qualifying examination for the admission to B. Tech. Programme in Institute of Technology, Nirma University?

Qualifying examination for the admission to B. Tech. Programme in Institute of Technology, Nirma University is std. XII (10+2) with the percentage of marks as to be decided by the Government of Gujarat under the rules of admission and JEE (Main)-2025. Candidate must appear for Paper-I of JEE (Main)-2025 entrance examination, who apply under NRI-Sponsored Category.

Q. 6. I have passed my std. XII (10 + 2) examination with Physics, Chemistry and Mathematics (science stream) subjects in 2025 from a state board other than Gujarat State Higher Secondary Education Board? May I apply for B.Tech. Programme at Institute of Technology, Nirma University?

Yes, you may apply for B. Tech. Programme at Institute of Technology, Nirma University.

Q. 7. I passed std. XII (10 + 2) examination with Physics, Chemistry and Mathematics subjects in 2023 (or earlier) from a state/central board? May I apply for B. Tech. Programme 2025 at Institute of Technology, Nirma University?

Yes, you may apply. However, you must have appeared in Paper-I of JEE (Main)-2025 entrance examination if applied under NRI-Sponsored Category Seats. Candidate who has passed the qualifying examination from the school located in India (having NRI status) have to appear in Paper-I of JEE (Main)-2025 Entrance Examination.

Q. 8. Whether JEE (Main)-2025 All India Rank (CRL) is required at the time of application submission?

Yes, JEE (Main)-2025 rank is required at the time of submission of the application. Also, make sure that you have enter correct JEE (Main)-2025 Application Number, Roll Number and Date of Birth as per the Admit Card of JEE (Main)-2025.

Q. 9. Is there any quota for OCI/PIO/CIWGC/FN for admission to B. Tech. programme at Institute of Technology, Nirma University?

Yes, 15% supernumerary seats are available for admission to OCI (Overseas Citizen of India) / PIO (Persons of Indian Origin) and foreign students. Out of this about one-third i.e. 5% seats are reserved for Children of Indian Workers in Gulf Countries (CIWGC) and South East Asia. Please contact the International Relation Office for further details.

Q. 10. If I am awarded Letter Grade/ Performance Indices/Graded Point Average instead of percentage marks / Percentile in standard 12th mark sheet, do I need to submit equivalent marks, separately?

Yes, equivalent certificate from the school authorities is required on the day of counseling for admission.

Q. 11. How do I inform you about correction of marks for the subjects Physics (P), Chemistry (C), and Mathematics (M), if any, after re-assessment?

The candidate has to inform admission office (preferably in person) about the correction in marks of above-mentioned subjects. Alternatively, you may send E-mail of the scanned copy of corrected mark sheet. Do not forget to mention your Registration No. in the E-mail.

Q. 12. How do I know about merit list? How will I be informed about the counseling session?

A provisional merit list with detailed programme of counseling will be displayed on the website URL (<https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>).

Counseling for admission will be carried out offline. Details of the same will be made available on the website.

Q. 13. Do I have to come personally at Institute of Technology, Nirma University for the cancellation of the admission?

No, Candidate can cancel his/her admission online through cancellation module by login to their account. Candidate has to submit the original fees paid receipts, admission order etc., within one week from the cancellation date to the Institute through Post/Courier.

Q. 14. Do you have on-campus hostel facilities for the students of B. Tech. Programme?

No. At present Nirma University is not offering on-campus hostel facilities to students of B. Tech. programme. The campus hostel facilities are available for PG programme students only. However, Guidance for the accommodation is provided. Further, NERF offers a bus facility to all the students (on chargeable basis) which ply from every corner of Ahmedabad city and Gandhinagar.

Q. 15. Which categories of people will be considered as NRI for admission to B. Tech. Programme?

Following categories of people will be considered as NRI for admission to B. Tech. Programme:

1. Passport of an applicant indicating his/her status as '**Non-Resident Indian**'.
2. Certificates of Non-Resident Indian issued by the Indian Embassy/Indian Consulate of the Country where the Non-Resident Indian is residing.

Q. 16. Which documents are required from the Sponsor to apply under NRI-Sponsored Category Seats to B.Tech. Programme?

The following documents are required from Sponsoring person.

- An Affidavit from sponsoring person (as per given Performa on the website).
- Photocopy of Passport of Sponsoring Person.
- Residence proof of Sponsoring person.
- NRI Status Certificate of Sponsoring person. The following documents are valid to prove NRI Status:
 - A certificate from employer, mentioning his/her status as NRI in case of Sponsor is on work visa (H1).
 - NRI/NRO Bank Account in the name of Sponsor in India.
 - Rent Agreement in foreign country mentioning the name, address of sponsor.
 - NRI Status Certificate issued by Indian Embassy or Indian Consulate of the Country where the Non-Resident Indian is residing.

Q. 17. From where the format of affidavit is available?

The format of Affidavit is available on admission **website URL**

Q. 18. How to prepare and submit the Affidavit from Sponsor to apply under NRI-Sponsored Category Seats to B.Tech. Programme?

The Sponsor can download the format of affidavit from the admission **website URL** **(<https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>)** and do the notarization process of the particular country and submit.

- If the affidavit is being prepared in foreign country, sponsor has to follow the affidavit/notarization of respective country.
- If provision of notarization is not available in a particular country, sponsor has to get endorsed affidavit from Indian Embassy/Indian Consulate situated in the respective country.

- If affidavit procedure is being carried out in India by NRI Sponsor, in that case proof of his/her presence in India at the time of affidavit must be enclosed in the form of a photocopy of those pages of passport having immigration stamp.
- The signature of sponsor in affidavit must match with the signature done in his/her passport.

Q. 19. Is there any provision to submit the affidavit from sponsor at the time of counseling?

No, but the candidate has to submit before the counseling date.
