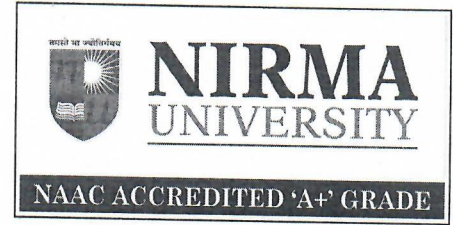

Sub: **Institution of new courses of study under various Faculties under Nirma University along with academic regulations and eligibility criteria**

It is hereby notified for information of all concerned that the Board of Governors in its meeting held on 29.03.2025 under resolution No. 3(B), taking into consideration the recommendation of the Academic Council, has resolved to approve **institution** of following new courses of study under various Faculties with their academic regulations and eligibility criteria, to be made effective for the students to be admitted in the respective programme from academic year 2025-26 onwards as per **Appendix-A** attached herewith:

- i. **Integrated B. Tech. (Mechanical Engineering)–Master of Business Administration** under Faculty of Management
- ii. **M.Tech. in Electronics & Instrumentation Engineering (Robotics and Artificial Intelligence)** under Faculty of Technology & Engineering.
- iii. **Doctor of Pharmacy (Post Baccalaureate)** under Faculty of Pharmacy (*lateral entry in the fourth year for the students completed B.Pharm. programme*)

Institution of new courses of study under various Faculties along with academic regulations & eligibility criteria, and intake

A. Institution of course of study:

- i. A new programme- “**Integrated Bachelor of Technology (Mechanical Engineering) – Master of Business Administration**” be added at Serial-3 as sub-clause-**‘5(a)’** under ‘3. Faculty of Management’ of ‘Institution of New Course Studies’ (as amended) published vide notification No. NU-856 dated 04.03.2005. After the amendment, the above clause will read as under (amendments are shown in **bold** letters):

- ii. A new programme- M.Tech. in Electronics & Instrumentation Engineering (**Robotics and Artificial Intelligence**), be added at “2). Master of Technology (Regular) in:” as sub-clause **‘17’** under ‘1. Faculty of Technology & Engineering’. After the amendment, the above clause will read as under (amendments are shown in **bold** letters):

- iii. A new programme- **Doctor of Pharmacy (Post Baccalaureate)** under Faculty of Pharmacy (*lateral entry in the fourth year for the students completed B.Pharm.*), be added as serial '**16**'. After the amendment, the above clause will read as under (amendments are shown in **bold** letters):

B. Eligibility criteria for admission and Determination of merit:

The eligibility criteria and determination of merit of above instituted courses will be at par with the existing Integrated B.Tech.(CSE)-MBA and M.Tech. programmes, respectively.

The admission eligibility criteria for Doctor of Pharmacy (Post Baccalaureate) shall be as prescribed by the Pharmacy Council of India from time to time.

C. Intake:

- for **Integrated B.Tech. (Mechanical Engineering)-MBA** programme: 60
- for **M.Tech. in Electronics & Instrumentation Engineering (Robotics and Artificial Intelligence)** programme: 18
- for **Doctor of Pharmacy (Post Baccalaureate)** programme: 10

D. Academic Regulations:

The academic regulations applicable to the existing Integrated B.Tech.(CSE)-MBA and M.Tech. programmes shall be made applicable mutatis-mutandis to Integrated B.Tech. (ME)-MBA programme and M.Tech. Electronics & Instrumentation Engineering (Robotics and Artificial Intelligence) programme, respectively. Further, so far as the clause 'R.BTM. 18: Award of Degree' is concerned, the nomenclature of the degree for Integrated B.Tech. (ME)-MBA programme shall remain at par with the nomenclature as mentioned under the institution of course of study.

The academic regulations of Doctor of Pharmacy (Post Baccalaureate) shall be at par with the existing Pharm.D. programme. However, so far as admission eligibility criteria is concerned, the same shall be as prescribed by the Pharmacy Council of India from time to time. Further, the nomenclature of the degree for the said programme shall remain at par with the nomenclature as mentioned under the institution of course of study.
