

**Cancellation of Admission and Refund Policy**

**ALL INDIA CATEGORY & NRI/NRI-SPONSORED CATEGORY**

**Cancellation of Admission:**

- Candidates can cancel their admission only through the “Seat Cancellation” tab available in the Online Cancellation Module on their login dashboard. The URL is as under:

- The candidate must accurately fill-in the cheque details and upload a clearly visible copy of the cancelled cheque along with the cancellation request. **A cancelled cheque copy must be submitted from a bank account held in the name of the candidate or either parent (father or mother). No other account details will be accepted.**
- Refunds will not be processed if incorrect cheque details / cancelled cheque without IFS Code, Full Name of Account Holder, Account Number / cancelled cheque is not uploaded / cancelled cheque not visible properly.
