Academic Eligibility for B.Pharm Admissions:

Candidate shall have passed the qualifying examination with minimum eligibility criteria of percentage of marks in the subjects as prescribed by Govt. of Gujarat from time to time. Generally these subjects are Physics and Chemistry and Biology or Mathematics. Merit list is prepared based on HSC (10+2) marks, the entrance test is not required for CIWGC/OCI/FN category.

Academic Eligibility for Pharm.D. Programme:

Candidate shall have passed the HSC exam with Physics, Chemistry and Maths or Biology or D. Pharm Degree. Merit list is prepared based on HSC (10+2) marks, the entrance test is not required for CIWGC/OCI/FN category.

Academic Eligibility for M.Pharm Programmes Admissions:

Pharm) from a recognised university with minimum 55% of aggregate marks* or equivalent Cumulative Grade Point Index (CGPI) or any other qualifying degree examination considered as equivalent of B.Pharm degree by Nirma University, Ahmedabad with minimum 55% marks* or equivalent CGPI. (*As per AICTE norms).
- · Candidates who are appearing for the final semester of qualifying examination (B. Pharm) can also apply. In such case, the candidate is required to submit the result as soon as the same is available either by email or by fax (scanned image) before the date as mentioned on the website.

Merit list prepared based on Bachelor's Degree marks, the entrance test is not required for CIWGC/OCI/FN category.

ADMISSIONS UNDER THE CATEGORIES OF CHILDREN OF INDIAN WORKERS IN GULF COUNTRIES AND SOUTH EAST ASIA (CIWGC-SEA), PERSONS OF INDIAN **ORIGIN (PIO) AND FOREIGN NATIONALS (FN)**

<u>CIWGC-SEA:</u> The candidates whose parent are working at Gulf countries or South East Asia are only eligible under this category.

PIO: The Persons who are citizens of other countries (except Pakistan and Bangladesh) who at any time held an Indian Passport, or who or either of his parents or any of his grand parents was a citizen of India by virtue of the provisions of the Constitution of India or Sec 2 (b) of Citizenship Act, 1955 (Act No. 57 of 1955) are only eligible under this category.

FN: The citizens of all countries other than India, who are not of Indian origin as defined under PIO are eligible under this category.

He/She should have passed any other qualifying degree/diploma examination considered as equivalent by Nirma University with minimum % of marks as prescribed by the AICTE from time to time or equivalent CPI.

Merit list prepared based on Bachelor's Degree marks, the entrance test is not required for CIWGC/OCI/FN category.

Academic Eligibility for MCA Admissions:

The students seeking admission in the First Year of MCA Programme leading to Master Degree of Computer Applications shall have to be graduated from the university of Gujarat state or any recognized examinations considered equivalent by the Nirma University with % of aggregate marks under 10+2+3 pattern as prescribed by the Govt. of Gujarat from time to time.

In addition to the above, the candidates must have passed Std. XII (HSC) examination or its equivalent examination with Mathematics or Business Mathematics or Statistics as one of the subjects. The candidate who has taken one of these subjects during graduation will also be eliqible.

Tech./B.E. Biotechnology, Physiotherapy or Biomedical Engineering with at least 50% marks as aggregate of all the semester / years. The entrance test is not required for CIWGC/OCI/FN category.
